### Recording Studio Producer Presentation Assignment INDIVIDUAL Assignment

#### Due Date: Monday, April 30

#### Who were some ground-breaking producers and what did they do that was important?

When you are in the studio, you will hear people talking about this person or that technique, and all of those things come from a rich history of groundbreaking producers trying new things.

Your assignment:

Learn about one of the producers below, and teach the class:

- What did the person do that was new/different?
- How did they do it? (physically what microphones, equipment, or techniques did they use?)
- What did people think about it at the time?
- What do people think about it now?
- Hand in (or email) a typed paper answering the questions above, and including a properly formatted bibliography (see bibliography handout).

HOW you teach the class is up to you. You could demonstrate the technique the producer used; you could play us clips of some of their recordings; think about what makes a presentation interesting to you and try to share your information with us in a way you would find interesting.

Your presentation should take between 5-15 minutes, and should thoroughly answer each bullet point above.

# Bibliography

# 1. What is a Bibliography?

A bibliography is a part of any paper that lists the sources of information that are not the author him or herself. It is a simple list of sources, usually in alphabetical order.

# 2. When do I need to cite a source?

Any time you write down information that did not come from your own head, but instead came from a website, book, or other person, you MUST give credit. Otherwise you are plagiarizing.

# 3. How do I cite a source in my writing?

It is important to cite sources in the middle of your writing as well as at the end in your bibliography. You can use parenthetical citations to do this. Immediately after the idea you share, simply put the author's name and the year of publication in parentheses (Levi, 2013). If the source is a website, you would put the name of the website (Wikipedia, 2013). In the bibliography, you will expand on that information.

# 4. When do I need to put something into my own words?

ALL THE TIME! If you feel that you cannot possibly say something better yourself, then you MUST use quotation marks to show that you are using someone else's words: "Ms. Levi's eloquence could not be replicated, nor could her poetic syntax be replaced" (Levi, 2013). Only do this a few times per paper. Otherwise, PUT IT IN YOUR OWN WORDS!

#### 5. How do I format my information?

Bibliographies need to be formatted very specifically. If you take something from a book, your citation should look like this:

Author, A. A. (Year of publication). Title of work: Capital letter also for subtitle. Location: Publisher.

The website, <u>www.bibme.org</u> is the best shortcut invented. It will format your information FOR you if you copy in the important pieces of information. If that doesn't work, you can always go here:<u>http://owl.english.purdue.edu/owl/resource/560/01/</u> and copy their formatting advice.

#### 6. What should a finished bibliography look like?

It should be a list of correctly formatted sources in alphabetical order by author (or by website if no author exists). See below:
